Naomi Kikoler is the Director of the Simon-Skjoldt Center for the Prevention of Genocide. As the Center's Deputy Director, she led the Center's policy engagement with the United States government and its work on Bearing Witness countries, including undertaking the documentation of the commission of genocide by ISIS. Previously she developed and implemented the Global Centre for the Responsibility to Protect's work on populations at risk and efforts to advance R2P globally and led the Centre's advocacy, including targeting the United

Nations Security Council.

She has also worked for the UN Office of the Special Advisor on the Prevention of Genocide, the Office of the Prosecutor at the UN International Criminal Tribunal for Rwanda, the Brookings-Bern Project on Internal Displacement at the Brookings Institution, and as an election monitor in Kenya with the Carter Center. She is a graduate of McGill University's Faculty of Law, Oxford University, where her master's thesis was on the Rwandan genocide, and the University of Toronto.



Dr. Azeem Ibrahim is a Director of the program on Displacement and Migration at the Center for Global Policy and a Chair of the Rohingya Legal Forum in Washington DC.

He completed his Ph.D. from the University of Cambridge and served as an International Security Fellow at the Kennedy School of Government at Harvard and a World Fellow at Yale. Over the years he has met and advised numerous world leaders on policy development and was ranked as a Top 100 Global Thinker by the European Social Think Tank in 2010 and a Young Global Leader by the World Economic Forum.

Dr Ibrahim is also author of "The Rohingyas: Inside Myanmar's Hidden Genocide" (Hurst & OUP) and "Radical Origins: Why We Are Losing the Battle Against Islamic Extremism" (Pegasus New York).



Aman Wadud is a Human Rights Lawyer based in Guwahati, India. He litigates before the Gauhati High Court and various Foreigners Tribunals across Assam. He defends people accused of being illegal migrants and those who are detained in various detention centers in Assam. He represented several detainees, which led to their release after years of detention. Aman has worked extensively on the NRC process and has travelled to various districts of Assam to educate people about the NRC. He has also been organizing training programs for lawyers who work before the Foreigners Tribunal.



Ashutosh Varshney is Sol Goldman Professor of International Studies and the Social Sciences and Professor of Political Science at Brown University, where he also directs the Center for Contemporary South Asia. Previously, he taught at Harvard and the University of Michigan, Ann Arbor. His books include *Battles Half Won: India's Improbable Democracy*, *Ethnic Conflict and Civic Life: Hindus and Muslims in India*, *Democracy, Development and the Countryside: Urban-Rural Struggles in India*, and *India in the Era of Economic Reforms*. His honors include the

Guggenheim and Carnegie fellowships and the Gregory Luebbert Prize. He is a contributing editor for *The Indian Express*, and his guest columns have appeared in many other newspapers, including the *Financial Times*. He is editor of the Modern South Asia Series, published by Oxford University Press, New York.
